ASSUMPTION OF THE RISK AND WAIVER OF LIABILITY RELATING TO CORONAVIRUS/COVID-19

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited or limited the congregation of groups of people.

Granite Creek Community Church (GCCC) has put into place preventative measures to reduce the spread of COVID-19; however, GCCC cannot guarantee that you or your child(ren) will not become infected with COVID-19. Further, attending GCCC or GCCC related activities could increase your risk and your child(ren)'s risk of contracting COVID-19.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren) and I may be exposed to or infected by COVID-19 by attending GCCC or GCCC related activities and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed or infected by COVID-19 at GCCC related activities may result from the actions, omissions, or negligence of myself and others, including but not limited to, GCCC employees, volunteers, and GCCC related activity participants and their families. I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child(ren) may experience or incur in connection with my child(ren)'s attendance at GCCC or participation in GCCC related activities ("Claims"). On my behalf, and on the behalf of my child(ren), I hereby release, covenant not to sue, discharge, and hold harmless GCCC, its employees, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, cost or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of GCCC, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any GCCC related activity. I understand and agree that the law of the State of California will apply to this Waiver of Liability.
